In Memory and Thanks to Robert O. Greathouse Jr. **Past District** Chairman & MMLMD

**Founding Father** 

Bob Greathouse passed away October 23, 2009, at the age of 82, at the place he loved the most, his home on Mt. Morris Lake. His wife Carol and his family were present.

Bob was good friend and leader of the Mt. Morris Lakes Management District for many years. He loved the lake life and committed himself to lake improvement during the early years of the lakes district. Even though Bob did not retire until 1989, he was MMLMD Treasurer from 1977 to 1983 and its Chairman from 1983 to 1995. Bob and other commissioners usually met in the evenings at the old Town Hall due to their busy schedules.

In 1979 Bob was first involved with addressing the aquatic plant problem in the lakes. Access to piers and through channels was a big problem. Bob did initial inquiry into the feasibility of using harvesting equipment to improve the lake access. He identified a state grant program for purchasing harvesting equipment and successfully obtained the grant for purchase of the MMLMD first harvesting equipment in 1983. Similarly in 1992, he headed the grant application process and the purchase of new harvesting equipment and slow-no-wake buoys. Bob forged a relationship with the best harvester builder in the state, Aquarius Systems, and bought the harvester at the best price including training for the operators.

During Bob's time as commissioner, it was customary that a picnic was held after the Mt. Morris Lakes Management District annual meeting. The potluck affair was well attended and Bob along with his wife, Carol were organizers. Bob is remembered to have provided roasted pig as well!

Bob was a great mentor to new commissioners. He would quickly get to know people and introduce them to the concept of lake management and the Chapter 33 Laws. He always attended the Wisconsin Lakes convention and took on the role in helping other commissioners meet state officials and other lake district managers. Bob knew what all the exhibits were about, and advised commissioners what key presentations to attend that had valuable information for the district.

Bob was also one of the founders and leaders of the Mt. Morris Mountaineers Snowmobile Club. He was a familiar figure on the trails driving the big Alpine Snow Trail Groomer to keep the club trail in peak driving condition. During many winter years, Bob could be found on Lake C in his cozy ice fishing shanty, enjoying a good day with friends.

The MMLMD expresses its appreciation for Bob's strong and insightful leadership that contributed much to the District's organization and operation in its formative years.

#### SHORELINE MAINTENANCE REGULATIONS PASSED

**NR115:** A few letters and numbers that comprise a new set of regulations that will become more important to the lakeshore homeowner who may plan future improvement to their property. The changes in the regulation will not impact owners of existing homes. However, anytime you plan to expand, improve, remodel, or change the appearance of your property regarding tree cutting, land digging, sandy beaches, stairs, adding new paved areas, piers rafts... then you need to check the regulation.

NR115 specifies what can or can not be done in three zones in your property, starting from the shoreline high water mark:

Zone 1: 0-35 feet- Unlimited maintenance to principle building

Zone 2: 35-75 feet- Vertical expansion only - principle building

Zone 3: 75-300 feet- Vertical/horizontal expansions regulated

In each of these zones, there are guidelines concerning what you can do to your principle building. For more information regarding this code, get publications from the DNR or visit:

#### SOME LAKE BOATING USAGE REMINDERS

Each of Mt. Morris lakes has its own environment, and its own natural "logical usage" rules that make sense for that lake. Regardless of what's legal, it's what's more appropriate for the health of the lakes that counts! In that regard, Alfson Lake (A) is small, fishing oriented, not suitable for full wake boating; Russell (B) and Emerald Lakes (E) are a combination fishing, kayaking, and "park your boat & swim" type quiet lakes; Hannah Lake (C) is a fragile fishing system, canoe/kayaking, with limited full wake use. Morris Lake is a full-out ski/tubing lake during the day, a quiet kayaking/fishing lake in the evening. Boats should be at no-wake within 100 ft of the shore (ski drop-off excluded). Personal Water Craft need to be 200 ft. from shore!!!

Boats pulling tubes with people in them at "no-wake" through channels/lakes after ski hours still violate ski laws. Boats pulling skiers/tubes - Required to go counter-clockwise. Boats navigating through lakes without pulling anyone are **not required** to do so!
